The undersigned corporation, for the purpose of amending its Articles of Incorporation and pursuant to the provisions of the "General Not For Profit Corporation Law" of the State of Missouri, hereby executes the following Articles of Amendment:

1. The name of the corporation is Jubilation Ministries, Inc.
2. All members have voting rights with respect to amendments.
3. At a special meeting of the members of the Board of Directors, held on February 8th, 1978, same receiving the votes of a majority of the directors then in office, the Board of Directors adopted a resolution amending the Articles of Incorporation and directing that such resolution be submitted at a special meeting of the members of the corporation to be held on February 8th, 1978, immediately following the special meeting of the Board of Directors held on February 8th, 1978, for approval or disapproval.
4. At a special meeting of members held pursuant to call and waiver of notice by all members, at which meeting a quorum was present and which meeting was held on February 8th, 1978, same receiving at least two-thirds (2/3) of the votes entitled to be cast by the members of the corporation present or represented by proxy at such meeting, the said resolution of the Board of Directors amending the Articles of Incorporation was approved by resolution adopted by the members.
5. Article V is amended in accordance with said resolutions by adding subparagraphs D and E thereto as follows:
 - D. The corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from United States income tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law nor by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law.

E. Upon the dissolution of the corporation, the Board of Directors shall, after paying, or making provision for the payment of, all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious or scientific purposes, as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue law, as the Board of Directors shall determine. Any of such assets not so disposed of shall be disposed of by the Circuit Court of the county in which the principal office of the corporation is then located, exclusively for such purposes, or to such organization or organizations as said court shall determine, which are organized and operated exclusively for such purposes.


WHEREAS, **JUBILATION MINISTRIES, INC.**
